STANDARD SCOPE

- Plan and provide Layer 2 Virtual/Physical network requirements for Nutanix Cluster (see Pre- Requisites); this service does not include configuring customers Ethernet switches
- Rack installation and in-rack cabling
- Nutanix Cluster deployment & configuration including firmware and Acropolis
- Hypervisor cluster deployment & configuration
- Hypervisor vSwitch configuration (up to 2 vSwitches and 5 Port Groups/VLANs)
- As built documentation with Architectural design and test results
- Prism Central, SSP, Calm architectural overview
- Deploy and configure Prism Central and Calm in your Nutanix environment including configuring up to two Nutanix Clusters
- Publish a blueprint from the Nutanix Global Marketplace to your PC instance
- Demonstrate Calm personas, constructs and actions using this blueprint
