

WEEE Collection and Recycling Arrangements in Luxembourg

Nutanix's WEEE producer registration number in Luxembourg is D13/00017

Nutanix equipment is sold in Luxembourg by Channel Partners. The Channel Partner imports the equipment into Luxembourg. Thus, the Channel Partner has the legal responsibility to:

- Register as the WEEE producer in Luxembourg
- provide arrangements for collection and recycling of WEEE arising from Nutanix equipment that the Channel Partner sells in Luxembourg

Under the Luxembourg Waste Electrical and Electronic Equipment legislation that came into force on August 13th 2005, for equipment that you buy from a Nutanix Channel Partner after August 13th 2005, the Channel Partner is required to provide arrangements for the collection, treatment, recycling and recovery of WEEE that your new purchase replaces, on a one-for-one, like-for-like basis. The old equipment that your new purchase from the Nutanix Channel Partner replaces is referred to as Historic WEEE.

Under the WEEE Ordinance, the Channel Partner is also required to provide arrangements for the collection, treatment, recycling and recovery of any electrical and electronic equipment that you buy from the Channel Partner after August 13th 2005 when that equipment eventually becomes waste. This is referred to as New WEEE.

Nutanix has decided to provide WEEE collection and recycling on behalf of its Dealers in Luxembourg.

Nutanix products are very competitively priced. Any new increase in operating costs for manufacturers such as Nutanix is normally reflected in a price increase in the product. However, instead of increasing the prices of our products, Nutanix has decided to share these new environmental costs directly with our customers. We believe in being transparent with you on any new environmental costs that our products need to address.

Our approach to sharing these new environmental costs is:

- Nutanix pays for the costs of treatment, recycling and recovery of the WEEE to meet the targets set by the WEEE Ordinance;
- Nutanix pays for the costs of data management and reporting to the Federal Minister of Agriculture and Forestry, Environment and Water Management to demonstrate compliance with all administrative requirements of the WEEE Ordinance;
- you pay for transportation of your WEEE to Nutanix's appointed recycler in Luxembourg.

Nutanix has established a recycling contract with the European Advanced Recycling Network (EARN) and will cover any costs of treatment, recycling and recovery of the equipment on arrival at the EARN recycling facility in Luxembourg. All New WEEE that arises from the purchase of Nutanix products is classed as non-hazardous waste.

It is your responsibility to arrange and pay for costs of collection and transportation to the recycler. In order to meet waste regulations in Luxembourg, you should use one of the following carriers (which will hold a valid Waste Carriers licence prior to producer take-back obligations beginning in Luxembourg):

To comply with the Luxembourg waste transport regulations the transport of your waste to the recycler must be accompanied by suitable documentation.

In order to comply with this legislation and to enable EARN to identify Nutanix equipment upon arrival at the recycler's address, please complete the attached label with your company details and attach it to a suitable box for transport to EARN.



Waste Electrical and Electronic Equipment for Recycling from Nutanix Customers

Under the Luxembourg WEEE Regulations, when customers buy new electrical and electronic equipment from Nutanix they are entitled to send old equipment for recycling on a one-for-one, like-for-like basis. Customers are also entitled to send the new Nutanix equipment for recycling when it ultimately becomes waste. Nutanix has established a recycling contract with the European Advanced Recycling Network (EARN) and will cover any costs of recycling the equipment in this box on arrival at an EARN recycling company. Please complete this label and attach it to a suitable box for transport of old equipment to EARN.
