

# WEEE Collection and Recycling Arrangements in Ireland

Nutanix equipment is sold in Ireland by distributors. The distributor imports the equipment into Ireland. Thus, the distributor has the legal responsibility to:

- Register as the WEEE producer in Ireland
- provide arrangements for arrangements for collection and recycling of WEEE arising from Nutanix equipment that the distributor sells in Ireland

Under SI 340/2005 Waste Management (Waste Electrical and Electronic Equipment [WEEE]) Regulations which came into force on August 13th 2005, for equipment that you buy from a Nutanix distributor after August 13th 2005, the distributor is required to provide arrangements for the collection, treatment, recycling and recovery of WEEE that your new purchase replaces, on a one-for-one, like-for-like basis. The old equipment that your new purchase from the Nutanix distributor replaces is referred to as Historic WEEE.

Under the Regulations, the distributor is also required to provide arrangements for the collection, treatment, recycling and recovery of any new electrical and electronic equipment that you buy from the distributor after August 13th 2005, when that new equipment eventually becomes waste. This is referred to as New WEEE.

Nutanix has decided to provide WEEE collection and recycling on behalf of its distributors in Ireland.

Nutanix products are very competitively priced. Any new increase in operating costs for manufacturers such as Nutanix is normally reflected in a price increase in the product. However, instead of increasing the prices of our products, Nutanix has decided to share these new environmental costs directly with our customers. We believe in being transparent with you on any new environmental costs that our products need to address.

Our approach to sharing these new environmental costs is:

- Nutanix pays for the costs of treatment, recycling and recovery of the WEEE to meet the targets set by the Waste Management (WEEE) Regulations;
- Nutanix pays for the costs of data management to demonstrate compliance with all administrative requirements of the Waste Management (WEEE) Regulations;
- you pay for transportation of your WEEE to Nutanix's appointed recycler in Ireland.

Nutanix has established a recycling contract with the European Advanced Recycling Network (EARN) and will cover any costs of treatment, recycling and recovery of the equipment on arrival at the EARN recycling facility in Ireland. All New WEEE that arises from the purchase of Nutanix products is classed as non-hazardous waste.

It is your responsibility to arrange and pay for costs of collection and transportation to the recycler. Under the Waste Management Act 1996, you should use the following carrier (which holds a valid Waste Carriers licence):

There is no legal requirement that WEEE be accompanied by documentation when transported in Ireland. However, in order to enable EARN to identify Nutanix equipment upon arrival at the recycler's address, please complete the attached label with your company details and attach it to a suitable box for transport to EARN.



# Waste Electrical and Electronic Equipment for Recycling from Nutanix Customers

Under the Ireland WEEE Regulations, when customers buy new electrical and electronic equipment from Nutanix they are entitled to send old equipment for recycling on a one-for-one, like-for-like basis. Customers are also entitled to send the new Nutanix equipment for recycling when it ultimately becomes waste. Nutanix has established a recycling contract with the European Advanced Recycling Network (EARN) and will cover any costs of recycling the equipment in this box on arrival at an EARN recycling company. Please complete this label and attach it to a suitable box for transport of old equipment to EARN.
